NB Court System

- Province is responsible for the administration, maintenance and function of all levels of courts on a day-to-day basis.
- All family law actions start at the Court of Queen's Bench, Family Division, (Family Court); child and adult protection, adoption, spousal rights and obligations, child rights and obligations, division of marital property, and divorce.
- Family Division has 8 court locations - Edmundston, Woodstock, Fredericton, Saint John, Moncton, Miramichi, Bathurst and, Campbellton.

Family Services Act

- Married / Common Law Spouses / Parents
- Best Interests of the Child
- Custody
- Access
- Child and/or Spousal Support
- Exclusive Possession of the Home
- Restraining Orders

Marital Property Act

- Marital Property Division

Protections- Family Violence

NB Family Services Act

- Ex-Parte (Rule 37.04)
- Restraining Orders
 - married spouses living separately (FSA s.128)
 - when a custody order is made (FSA s. 132(1))
- Exclusive Possession of the Marital Home with an application for child/ spousal support (FSA s.116(d))
- Criminal Code charges

Federal FHRMIR Act

- Ex-Parte
- Emergency Protection Orders
- Married or common law
- One partner must be First Nation Member or Indian
- Family Violence defined (s. 16(9))
- Exclusive Occupation- 90days

Family Law- Federal

- ***Divorce Act*** - Petition for Divorce to end marriage:
 - Lived separate and apart for 1 year (no fault divorce)
 - Adultery
 - Mental or Physical Cruelty
- ***Child Support Guidelines***
 - Rules and Tables - Federal legislation
 - Judges required to apply the guidelines in all child support matters heard at court
- ***Spousal Support Advisory Guidelines***
- ***Civil Marriage Act***
- ***Family Homes on Reserves and Matrimonial Interests or Rights Act***

Provincial Plans Re: Implementation

- Interdepartmental Implementation Committee - provides strategic direction to prepare the court system and other stakeholders for the new *Act*;
- Government officials and representatives from Aboriginal Affairs Secretariat and ECO - Women's Equality Branch - Violence Against Aboriginal Women
- Three sub committees formed to work on addressing the impact of the federal act: Court Preparation; Enforcement and; Communications.

Provincial Plans Re: Implementation

- Designation of a judge to hear Emergency Protection Orders
- Federal Regulation for EPO's
- Considering amendments to the NB *Rules of Court*
- Determining if existing court forms need to be amended
- Communications / Education materials for the NB Judiciary, Court Staff , Sheriff Services, OAG- Crown Prosecutors, Legal Aid etc.

- Free
- Voluntary
- Province-wide registration through a toll-free family law information line run in cooperation with PLEIS-NB 1-888-236-2444
- Available in both official languages in every judicial district



Family Advice Lawyer Service and Family Duty Counsel

- Family Advice Lawyer Services (advance legal info. for self represented) community based across N.B. 1-855-266-0266 or 506-658-2261 in the Saint John jurisdiction.
- Family Duty Counsel - Legal representation for individuals on first appearance where the “state” is on the other side.

Court Ordered Evaluations Support Program (COESP)

- Contested custody/access matters at court.
- Court ordered assessments to determine post separation parenting arrangements in the best interests of the children (custody and access).
- Voice of the Child assessments
- The amount of financial assistance depends upon income.
- Application forms at Family Court Offices or online at www.familylawnb.ca

Family Division Case Management Model – Saint John

- Provides streamlined access to services and expedient resolutions of family law disputes in the Judicial District of Saint John.
- Ensures appropriate and efficient streaming of cases in the family court system, particularly for self-represented litigants.
- A team of court staff led by a Case Management Master triages cases and manages them to early resolution. The model also includes: a Triage Coordinator, in-house mediation services, on-site advice lawyer services, family duty counsel, an on-site Family Law Information Centre and a rule of court which governs the case management model.

Family Support Orders Service (FSOS)

- Collects support payments from payers and their income sources and takes enforcement measures when support has not been paid.
- Payments can be made ‘over the counter’ at local SNB centres in approx. 40 locations.

Family Law Workshops - PLEIS

- “Navigating the Family Justice System” workshops designed to inform and educate self represented litigants on family law matters
- Topics covered include:
 - Doing Your Own Divorce;
 - Changing a Child Support Order;
 - Preparing for a Family Court Hearing;
 - Separation; Legal Considerations.
- A fee of \$20.00 fee is charged at some workshops, to cover materials

New Brunswick Legal Aid Services Commission

- Assists low income individuals deal with certain family law matters
- Gives priority to screening those cases that are urgent or can directly benefit children
- Financial means testing required to determine eligibility for covered services
